Sub: Preparation of panel for appointment as Intelligence Officer in the offices of the Directorate of Revenue Intelligence, under Delhi Zonal Unit, New Delhi in the pay scale of Rs. 6500-200-10500-Reg.

Sir,

The Delhi Zonal Unit of the Directorate of Revenue Intelligence is in the process of drawing a panel of suitable candidates for filling up the vacancies in its unit at Delhi, Amritsar, Jaipur and Ludhiana, in the grade of Intelligence Officer, in the pay scale of Rs. 6500-200-10500

It is proposed to fill up these vacancies by appointing, on deputation basis, suitable officers with a minimum of 3 years of service in the grade of Inspector. Officers, who have been granted financial up-gradation under ACP Scheme, are also eligible for the said post.


The selected officers, while working in the Directorate in the grade of Intelligence officer, will be entitled to a special pay of 10% of basic pay as defined in FR 9(21) (a) (I) in the revised scale subject to the prescribed ceiling of Rs. 800/- p.m. Normally, the deputation is for a period of five years which is extendable by another two years, subject to the willingness of the officer, his/her performance, and the concurrence of his parent Commissionerate.

It is requested that this circular may be brought to the notice of all the formations in your jurisdiction and the applications of willing officers forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may also be sent for evaluation by this Directorate.

01. Willingness of the officer.
02. CCR grading for the last 5 years (duly verified and attested).
03. Vigilance clearance.
04. NO-objection to relieve the officer in the event of his selection.
