Sub : Review & Data verification of IRS(C&CE) officers – reg

Reference is invited towards DGHRD's letter of even number dated 05.09.2011 wherein it was requested to forward the verified data of the Group A officers posted under your charge for updation of their History of Postings. An exhaustive list of officers, whose verified data/History of Posting is not available with DGHRD, was also forwarded alongwith the said letter.

2. The progress report so far regarding the receipt of verified data is not satisfactory and requires your personal attention. A total number of 656 officers were mentioned in Annexure A (whose verified data was completely not available) and 319 officers were mentioned in Annexure B (whose verified data was either not available or missing for some period) of the letter dated 05.09.2011. It is observed that out of above, only in 36 cases in Annexure A and 14 cases in Annexure B respectively, the verified data has been received till date. Non submission of verified data is causing hindrance in creating proper data base of IRS (C&CE) officers, which is basic requirement of HR management and also required for ensuing AGT-2012.

3. In view of the above, it is requested to look into the matter personally and send the verified data of officers of your zone by 31st December 2011, positively. Detailed list of officers of your zone whose verified data is either not available or missing for some period is again enclosed as Annexure A & B respectively for ready reference.
