Quotations are hereby invited from the different vendors for renovation of office Toilets at 4th Floor, 25, Princep Street, Kolkata – 700 072. The descriptions of works are as under:

- A. GO's Toilet: Floor area – 9'.3" x 4'.6" = 42 Sft.
1. Tiles on floor only – 42 Sft.;
 2. Painting on wall & ceiling – nearly 320 Sft.
 3. Covering of broken window by breaks;
 4. Installations of exhaust Fan (Khaitan)
 5. Change of wall Mirror.
- B. Common Toilet: Floor area : (12' x 4'.6") + (5' x 3'.9") + Wall area for Tiles (7' x 2'.5") = 91 Sft.
1. Tiles on Floor & Wall area = 91 Sft.
 2. Painting of Wall & Ceiling;
 3. Granite partition in between gents urinal;
 4. Installation of one additional urinal;
 5. Breaking of existing Pan & fixing of Commode & Cistern;
 6. Rectification of Door;
 7. Covering of broken window by ply wood;
 8. Installations of exhaust Fan (Khaitan).
- C. Ladies Toilets : Floor area (12'.6" x 4') = 50 Sft.
1. Tiles on floor 50 Sft.;
 2. Tiles on wall (3' x 2'.6") in front of Ladies Urinal;
 3. Resonaping Ladies Urinal;
 4. Change of Commode, Cistern and allied pipe line;
 5. Painting nearly 400 Sft.;
 6. Installations of exhaust Fan. (Khaitan).
- D. Others:
1. Change of basin with proper fittings;
 2. Making a platform for water cooler-cum-purifire Machine covering with Tiles and a guard for protection from basin water;
 3. All the above works are to be completed with proper drainage system.
